Welcome to the Nruthya Shakti Dance Academy (NSDA).

We are excited that you chose our academy to learn the various folk dance art forms of India.

Please read this registration form thoroughly before enrolling for lessons at NSDA. Once we receive your application, we will get in touch with you to better understand your needs, and place the student in the the appropriate class level.

Terms & conditions

FEES

Registration is **\$30.00** and is due at the start of the NSDA calendar year (August) or when joining NSDA (new students). This fee is **mandatory**.

NSDA regular class fees are **\$210.00** per quarter (Three months). Each month will have four classes. Elite class fees are **\$255.00** per quarter (Three months). Payment is due within the first week of the month, after which a late fee of **\$10.00** will apply. All NSDA students are required to participate in the annual performance show. A performance fee of \$70.00 will be collected three months ahead of the show and is non-refundable. For siblings of the primary student, a fee of \$30.00 (per sibling) will apply. This fee includes professional photography and/or video recording services and two complimentary tickets for the show. The announcement of the annual show date will be made in May. In the event of students' absence from the annual show (for any reason), they will be responsible for both the show participation fees and any costs associated with ordered costumes.

Note: Fees are subject to change and are non-refundable.



DRESS CODE & CONDUCT

NSDA students must remain in proper attire at all times. Acceptable attire includes Kurtis and Track Pants for boys and Salwar Kameez and Kurtis for girls. Jeans, shorts, skirts and short clothes are strictly forbidden. Students and parents must also maintain proper conduct and respect for faculty, student body, and studio facilities. NSDA will not tolerate any form of abusive language, racism, and misconduct-any student/parent resorting to such behavior will result in expulsion from NSDA.

CANCELLATIONS, MAKE-UPS & HOLIDAYS

NSDA will not honor any make-up classes for last-minute cancellations. NSDA will hold up to two make-up classes per quarter (Three months) based on studio and faculty availability. A make-up lesson (in person or online) will be held for any adverse weather cancellation.

NSDA will observe the following holidays:

Spring Break- based on the Plano ISD calendar Diwali- the day of Diwali and the next day Thanksgiving- Thursday to Sunday Christmas & New Year- Dec 24 - Jan 02 NSDA will remain closed all of July.

There will be no make-up lessons during this period. NSDA will provide four classes during March (Spring Break) and December (Christmas).

SHOWS & EVENTS

NSDA students get opportunities to perform at various shows and charity events throughout the year. Students sometimes have to take extra lessons to exhibit quality dance performances while representing NSDA. These lessons will be held on an asneeded basis. NSDA students get opportunities to perform at various shows and charity events throughout the year. Only show-ready students will be considered for event performances, and this selection is at the sole discretion of NSDA faculty.

COSTUMES

Costumes for the annual show and other performances must be purchased through NSDA only. Tailoring costs, materials, and shipping determine costume pricing. Parents/students must provide accurate measurements, preferably taken at the NSDA studio(s). Show costume costs are additional, and the parent/student is responsible for the cost of any costumes ordered. No refunds will be issued to students who withdraw from NSDA after placing a costume order. The costume will be sent to you once it becomes available.



DANCE THEORY & NATYASHASHTRA EXAMS

NSDA students are trained to be well-versed in dance theory and technical art forms. Theory exams will be conducted annually by outside examiners. These examiners are highly reputed dance teachers and experts in Indian dance forms. Exams are graded at the sole discretion of the examiner-scores will be passed on to NSDA and then on to students. NSDA will not entertain questions regarding exam gradings or conduct or allow any direct parental communication with examiners. The exam grading is a metric to measure student engagement and progress and will be used to decide student-level placement within NSDA. The theory examination is mandatory for all students.

WORKSHOPS

Every year, NSDA conducts multiple workshops in unique art forms. These workshops are mandatory for the Elite student group. Workshops for other levels and age groups are optional and will be organized based on participation count. All workshop fees must be paid in full in advance and are non-refundable.

ELITE TEAM

Every year, a few students get drafted into the Elite team. These students possess advanced dance skills, commitment, and good command of dance theory. They will undergo advanced training in dance choreography and theory. NSDA will identify and hold an audition for such students, and NSDA's decision on selection is at its sole discretion and will be considered final. Minimum age of 12 is required for the elite level. Students are expected to maintain high standards of the dance form and commitment. Students are also subject to demotion based on their performance/commitment. This decision is at NSDA's sole discretion and is considered final. Any student can opt-out of the Elite team at their sole discretion. Elite students get additional performance opportunities at events.

NAATYA KALAAKAAR COMPETITION

NSDA will hold an annual folk dance competition to promote folk dance and student leadership. This show is conducted by the elite student group and is open to anyone in the USA. Students/groups must present self-choreography. Any dance choreography taught in regular NSDA dance sessions will not be allowed. The competition entry fee is **\$15.00** and is non-refundable. This fee is subject to change.



MEDIA ASSETS

Parents/students can record dance sessions for future reference and practice. By acknowledging and downloading this form, you (parent/student) agree to be recorded in a group or individually. All media and recordings will not be redistributed or displayed on public sites or social media outlets without the prior consent of NSDA. NSDA will not be held responsible for any form of misuse of such property. NSDA reserves the right to use such media and assets for its website and marketing needs.
